### <u>SCHEDULE 1</u> PROHIBITION OF WAITING AT ANY TIME

#### 1. Un-named road between Brickfield Crescent and Queen's Road

Both sides of the un-named road between Brickfield Crescent and Queen's Road, from its junction with Brickfield Crescent for a distance of 47 metres in an easterly direction.

### 2. Bryntirion Road

- (i) The southern side of Bryntirion Road adjacent to the northern side of the property known as the Rectory from a point 10 metres west of the western side of the property known as the Rectory for a distance of 30 metres in an easterly direction and 4 metres in a northerly direction towards Park Lodge Bungalow.

#### 5. <u>Caedraw Road</u>

- (ii) The north western side of Caedraw Road opposite St. Tydfil's Court from the north eastern side of Caedraw Road for a distance of 45 metres in a north easterly direction towards Morlais Court and then for a distance of 24 metres in a south easterly direction alongside Morlais Court.

(iii) The south western side of Caedraw Road opposite Morlais Court from a point 4 metres north west of the south eastern boundary of Morlais Court for a distance of 20 metres in a north westerly direction.

#### 6. Victoria Street, Dowlais

- (i) The western side of Victoria Street, Dowlais, from a point 30 metres south of the south side of the entrance to Victoria House to a point 6 metres north of the north side of the junction with Odessa Street.
- (ii) The western side of Victoria Street, Dowlais from its junction with the southern side of Spring Street for a distance of 12 metres in a southerly direction.
- (iii) The western side of Victoria Street, Dowlais from its junction with the northern side of Spring Street for a distance of 5 metres in a northerly direction.

# 7. Chestnut Way, Gurnos

The northern side of Chestnut Way, Gurnos from the eastern side of its junction with Poplar Way for a distance of 10 metres in a north easterly direction.

#### 8. Poplar way, Gurnos

- (i) The eastern side of Poplar way, Gurnos from the northern side of its junction with Chestnut Way for a distance of 10 metres in a northerly direction.
- (ii) The eastern side of Poplar way, Gurnos from the southern side of its junction with the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove for a distance of 10 metres in a southerly direction.
- (iii) The eastern side of Poplar way, Gurnos from the northern side of its junction with the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove for a distance of 10 metres in a northerly direction.

# 9. <u>Unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove</u>

- (i) The northern side of the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove from its junction with Poplar Way to its junction with Alder Grove.
- (ii) The northern side of the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove from its junction with Alder Grove for a distance of 10 metres in an easterly direction.

- (iii) The southern side of the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove from its junction with Poplar Way for a distance of 10 metres in an easterly direction.
- (iv) Both sides of the eastern end of the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove from the eastern side of the access to the car park in an easterly direction to its cul-de-sac end including the three sides of the cul-de-sac end.
- (v) The southern side of the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove from the western side of the access to the car park for a distance of 10 metres in a westerly direction.

#### 10. Alder Grove, Gurnos

Both sides of Alder Grove, Gurnos from its junction with the unnamed access road leading from Poplar Way, Gurnos forming a cul-de-sac and leading to No. 60 Plane Grove for a distance of 10 metres in a northerly direction.

#### 11. Cefn Coed High Street

The south western side of Cefn Coed High Street from the entrance to the Cemetery to a point 10 metres south east of the south side of the junction with Pearces Court.

# 12. Norman Terrace

Both sides of Norman Terrace from its junction with Dane Street for a distance of 15 metres in a south easterly direction.

#### 13. High Street, Merthyr Town Centre

Both sides of High Street from its junction with Pontmorlais West southwards to the southern side of Church Street excluding the purpose built lay by's in Pontmorlais High Street and the loading areas in Pontmorlais High Street on the western side adjacent to no's 14 and 22.

#### 14. <u>Bethesda Street</u>

The northern side of Bethesda Street from a point 56 metres south west of its junction with the south western side of Brecon Road for a distance of 19 metres in a south westerly direction.

### 15. Penry Street

(i) The northern and north eastern side of Penry Street from its junction with the western side of Avenue De Clichy in a westerly then north westerly direction to the south eastern side of the rear access to the Fire Station.

- (ii) The north eastern side of Penry Street between the north western side of the rear access to the Fire Station and a point opposite the southern side of the Aberdare Road junction.
- (iii) The southern side of Penry Street from its junction with the western side of Avenue De Clichy in a westerly direction to the eastern side of its junction with the unnamed road leading to Merthyr College.
- (iv) The south western side of Penry Street from its junction with the western side of the unnamed road leading to Merthyr College in a north westerly direction to the southern side of its junction with Aberdare Road.

#### 16. <u>Dynevor Street</u>

- (i) The north eastern side of Dynevor Street from a point opposite the northern side of the Aberdare Road junction in a north westerly direction to the south eastern side of the access to The Daffodils Nursing Home.
- (ii) The north eastern side of Dynevor Street from the north western side of the access to The Daffodils Nursing Home in a north westerly direction to the south eastern side of its junction with Bethesda Street.
- (iii). The south western side of Dynevor Street from the northern side of its junction with Aberdare Road in a north westerly direction to the south eastern side of its junction with Heol S O Davies.

#### 17. Un-named road between Lower Thomas Street and Union Street

The southern side of the un-named road between Lower Thomas Street and Union Street, from the western side of Union Street for a distance of 2 metres in a westerly direction.

#### 18. Park Terrace, Trelewis

The north eastern side of Park Terrace, Trelewis from a point 100 metres south east of its junction with the southern side of Glyn Bargoed Road in a south easterly direction to its junction with Mackintosh Terrace.

#### 5. <u>Nantygwenith Street</u>

Both sides from its junction with the southern side of Swansea Road in a south easterly direction to a point opposite the common boundary of no's 16/17 Howell Close.

#### 6. Perrott Street, Treharris

Both sides of Perrott Street from its junction with the eastern side of Thomas Street in an easterly then northerly direction to its junction with Cardiff Road, excluding the lengths of purpose built lay by's along Perrott Street.

#### 7. Fox Street, Treharris

Both sides of Fox Street from its junction with Cardiff Road in a north easterly direction to its junction with the northern link road to Cilhaul excluding the lengths of purpose built lay by's along Fox Street.

#### 1. Pontmorlais High Street, Merthyr Town Centre
