

**MERTHYR TYDFIL CUNTY BOROUGH COUNCIL
(OFF STREET PARKING PLACES)(AMENDMENT No. 6) ORDER 2014**

Notice is hereby given that the Merthyr Tydfil County Borough Council in exercise of its powers under Section 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) as amended, the provisions of the Traffic Management Act 2004 (“the 2004 Act”) and all other enabling powers, intends to make the above Order.

This Order will amend the provisions of the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Consolidation) Order 2012 and the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Amendment No. 1) Order 2013 and the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Amendment No. 2) Order 2013 and the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Amendment No. 3) Order 2013 and the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Amendment No. 4) Order 2014 and the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Amendment No. 5) Order 2014 hereinafter referred to as “the Orders”. The effect of the changes to the Orders will be:-

1. The following car parks referred to shall forthwith be subject to the Tariff Schedule 2014a
 - a) Castle Multi-storey Car Park the extent of which is identified hatched black on Plan 35
 - b) Abermorlais Car Park the extent of which is identified hatched black on Plan 1
 - c) Civic Centre Car Park the extent of which is identified hatched black on Plan 6
 - d) Post Office Lane Car Park the extent of which is identified hatched black on Plan 25
2. The Tariff Schedule 2014 to the Orders shall be repealed and replaced by the Tariff Schedule 2014a as set out below and attached to the Merthyr Tydfil County Borough Council (Off Street Parking Places)(Amendment No. 6) Order 2014.
3. All references made to the “Tariff Schedule 2014” in the Orders shall hereinafter be replaced by the “Tariff Schedule 2014a”
4. The Schedule 4 2014 to the Orders shall be repealed and replaced by the Schedule 5 2014.
5. All references made to “schedule 4 2014” in the Orders shall hereinafter be replaced by “schedule 5 2014”

The provisions of the Orders shall otherwise remain unchanged in all other respects.

The Order and relevant documents and plans giving more detailed particulars of these proposals may be inspected at the Civic Centre, Castle Street, Merthyr Tydfil during normal office hours.
