288	Application for a permit to place tables and chairs on the public highway - The New Crown Inn, High Street, Merthyr Tydfil	<p>The Chair welcomed Mr Jorge D'Ascencao the applicant to the Meeting and outlined the procedure for the hearing.</p> <p>Joanne Baber referred to the 'Application for a Permit to Place Tables and Chairs on the Public Highway, The New Crown Inn, Merthyr Tydfil' report and led the Committee through the report.</p> <p>Andrew Jenkins Police Licensing Officer then referred to the report and led the Committee through the representations of the South Wales Police.</p>
