The above Order made on 21 December 1995, if confirmed will modify the Definitive Map and Statement for the area by adding to them a Byway Open to All Traffic as described in the Schedule to this Notice and indicated on the attached map by a bold black continuous line with arrowheads alternately above and below, between Points A-B-C-D-E.

A copy of the Order and Order map has been deposited and may be inspected free of charge at the office of the County Secretary and Solicitor, Mid Glamorgan County Council, County Hall, Cathays Park, Cardiff, CF1 3NE and at the offices of the Merthyr Tydfil Borough Council, Civic Centre, Castle Street, Merthyr Tydfil, CF47 5AN and can be so inspected, free of charge, during reasonable office hours from 11 January 1996 to 23 February 1996.

Copies of the above Order and map may be purchased from the Mid Glamorgan County Council, at the above address, at a price of £1.00.

Any representation or objection relating to the Order must be sent in writing to the County Secretary and Solicitor, Mid Glamorgan County Council, at the above address and be received not later than 23 February 1996 and it is requested that any objection or representation to the Order states the grounds on which it is made.

If no representations or objections are duly made to the Order or if any so made are withdrawn, the Mid Glamorgan County Council instead of submitting it to the Secretary of State for Wales, may itself confirm the Order. If the Order is submitted to the Secretary of State for Wales, any representations or objections which have been duly made and not withdrawn will be sent with it.

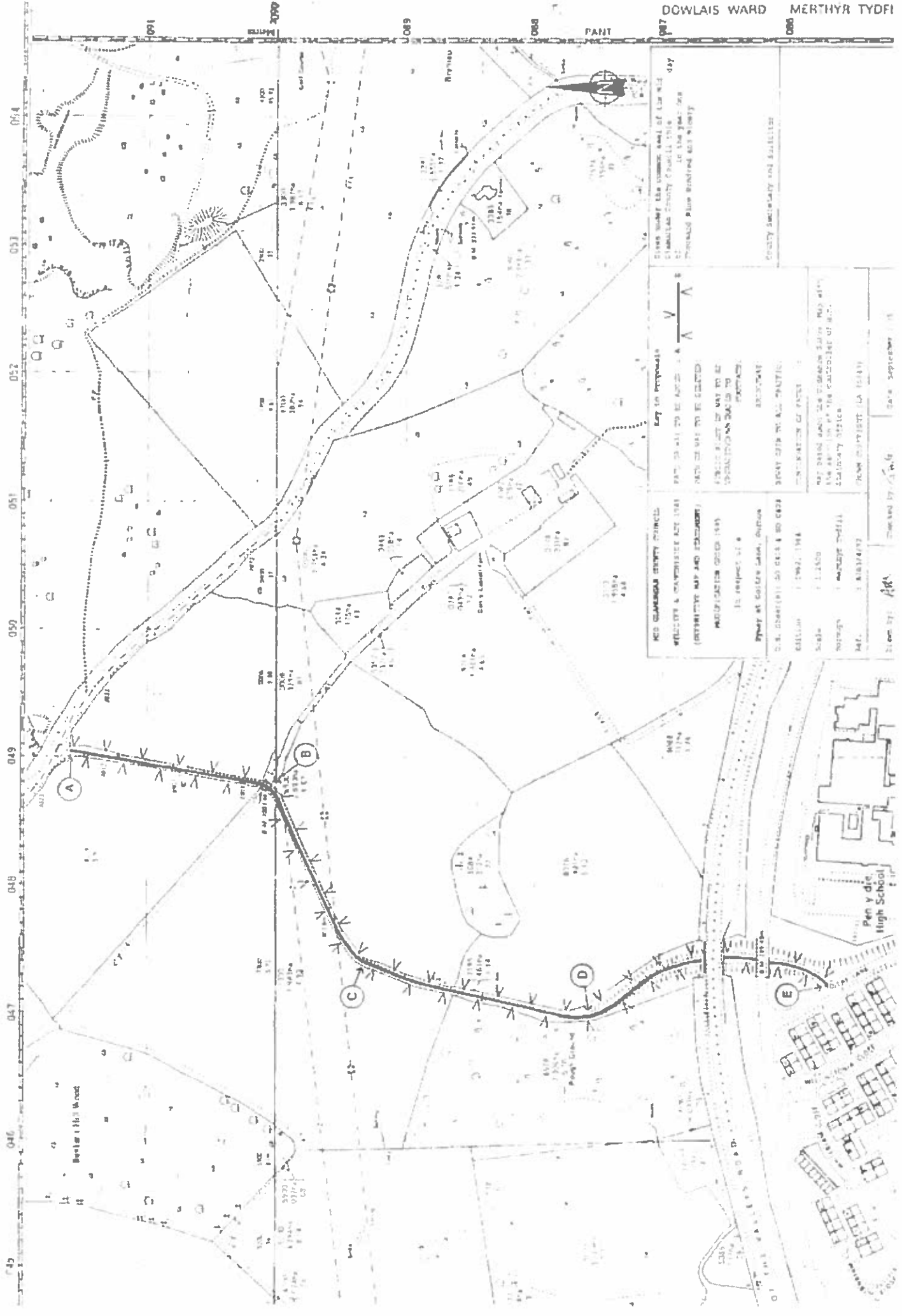
MODIFICATION OF DEFINITIVE MAP AND STATEMENT

DESCRIPTION OF PATH OR WAY TO BE ADDED

A Byway Open to All Traffic which commences at its junction with the maintainable highway known as Pont Sarn Road, Point A on the attached map (Grid Reference SO 04900916) and proceeds in a south-south-westerly direction for 157 metres to Point B on the attached map (Grid Reference SO 04870900) and then in a west-south-westerly direction for 155 metres to Point C on the attached map (Grid Reference SO 04740893) where it turns and runs in a south-south-westerly direction for 177 metres to Point D on the attached map (Grid Reference SO 04700876) and finally in a curved south-south-easterly direction for 208 metres to its termination on the maintainable highway known as Goitre Lane, Gurnos, Merthyr Tydfil, Point E on the attached map (Grid Reference SO 04720857), a total distance of 697 metres or thereabouts, shown on the attached map by a bold black continuous line with arrowheads alternately above and below the line, between Points A-B-C-D-E.

NOTE: THIS IS NOT PART OF THE ORDER BUT IS INTENDED FOR PUBLIC INFORMATION ONLY

It is proposed that upon confirmation of this Order for the section of Byway Open to All Traffic which runs between Points B-C-D-E on the associated map, to be the subject of a legal process which will prevent vehicles travelling along its length. This legal process will not be permanent in nature and may be revoked as and when considered appropriate to do so by the Highway Authority which will be the Mid Glamorgan County Council up until 31 March 1996 and the incoming Merthyr Tydfil County Borough Council thereafter.
