# Community Awards Guidance

A group wants to improve an area, develop a garden, clear up litter, make a mural, or give somewhere a lick of paint. An award could be given for the materials / professional help and the group can get volunteers to carry out the project.

## Information on Community Awards

**Background:** Biffa Landfill Services, who operate Trecatti Tip in Dowlais Top, allocate money to the Council for community benefit use. Money is then given to each electoral division in the County Borough for the Councillors to use for community projects and activities in their areas.

**What are Your Community Awards?** Any community group in the electoral division is eligible to apply, no matter its size or age. All Groups are welcome to apply, and any applications will be considered as long as it can bring benefits to the group or local community.
